#### **Working** to Prevent Utility Rate Increases

In the midst of a recession, many local residents have lost their jobs or seen their hours at work cut. This hasn't stopped the big utility companies from trying to squeeze even more profits from electric customers, putting an even greater strain on family budgets.

Rep. Harris fought against legislation pushed by ComEd that would make it easier for them to increase utility rates and cut the time the state would have to review rate increase proposals.

Even though Senate Bill 1652 passed the Legislature, Rep. Harris is urging the governor to reject the bill. For more information on how to help stop electric rate hikes, please contact Harris' constituent service office at (773) 348-3434.

## **Improving** Our State's Fiscal Outlook

Illinois is working to recover from the worst economic recession since the Great Depression. Rep. Harris knows that in order to create jobs, and to deliver essential health, education and safety services, we must get the state's fiscal affairs in order.

This spring, Rep. Harris helped implement a bipartisan, transparent and thorough budget process that cut the size and cost of government by more than \$2 billion and requires the state to live within its means.

Democratic and Republican lawmakers worked together in the House to rein in state spending and streamline the delivery of critical services. Many tough decisions had to be made, but Rep. Harris knows we cannot continue to ignore the very serious fiscal challenges the state continues to face.

# **Preserving** Vital Programs for Older Illinoisans



The governor pushed to eliminate both the Illinois Cares Rx and Circuit Breaker programs in his proposed FY 2012 budget. These are crucial programs that help Illinois seniors on fixed incomes save scarce dollars.

Rep. Harris voted to restore \$50 million to the Illinois Cares Rx program to help seniors with the high costs of prescription drugs and \$24 million to the Circuit Breaker program, which provides seniors with needed property tax relief.

## **Creating** Civil Unions in Illinois

After years of negotiations, Rep. Harris' fight for equality was rewarded this year with the passage of legislation permitting Civil Unions in Illinois. ### **Helping** End Abuse in Group Homes

In response to the recent findings of abuse and death of some of our state's most frail and vulnerable citizens in group homes, Rep. Harris authored House Bill 653, known as "Paul's Law," to increase protections for patients by requiring a more rapid review of any abuse allegation and requiring state regulators to take action if problems are found. The legislation also requires group home workers to undergo strict background checks.

## **Keeping** Dangerous Guns Off Our Streets

Gun groups pushed legislation allowing almost anyone to carry a concealed weapon near our homes, parks and on our streets. Rep. Harris helped defeat this measure that would have greatly endangered public safety.
